**ORDER**

**WHEREAS**, in terms of Section 14(1) of the NCTE Act, 1993, Sant Tapasvi Narayan Das Foundation, Street / Road-NH104, Purani, Vill-Bariyarpur, PO-Bariyarpur, Tehsil-Dumra, Town/City Sitamarhi, Dist-Sitamarhi, Bihar-843302 has applied for grant of recognition/permission to Sant Tapasvi Narayan Das Shikshan Sansthan, Plot No. 3027, 3035, 3026, 3034, 3033, Vill- Dostpur Khairvi, Po- Bariyarpur, Tehsil/Taluka- Bathnaha, Town/City-Sitamarhi, Dist.- Sitamarhi, Bihar-843302 (Code No.- ERCAPP2483) for B.Ed. Course online on 26.05.2015 for two year duration and hard copy received by Eastern Regional Committee of NCTE on 10.06.2015.

2. **AND WHEREAS**, as per the decision of 213<sup>th</sup> ERC Meeting held on 29<sup>th</sup> – 30<sup>th</sup> April, 2016 & 1<sup>st</sup> – 2<sup>nd</sup> May, 2016 formal Recognition order under clause 7(16) for conducting B.Ed. course was issued vide Order No.ER-213.6(i).313/ERCAPP2483/B.Ed. Course/2016/ 46122 dt. 02.05.2016 with an intake 50 (one basic unit) from the academic session 2016-17 to the institution.

3. **AND WHEREAS**, The institution preferred an appeal to NCTE HQs. and the Appellate Authority vide Order No. 89-472/E-7252/ 2017-Appeal/2<sup>nd</sup> Mtg.-2018/3<sup>rd</sup> & 5<sup>th</sup> Feb., 2018/64187 dated 16.03.2018 remanded back the case to ERC for considering the eligibility of appellant institution for grant of recognition for the 2<sup>nd</sup> unit taking into consideration the cut of date for current academic year. The matter was considered by ERC in 254<sup>th</sup> meeting held on 16<sup>th</sup> -17<sup>th</sup> April, 2018 and accordingly, Show Cause Notice was issued on 30.04.2018 to the institution. Reply of SCN dated 28.04.2018 received from the institution.

4. **AND WHEREAS**, The ERC in its 256<sup>th</sup> meeting held on 30<sup>th</sup> – 31<sup>st</sup> May, 2018 considered the appeal order as well as reply submitted by the institution and decided as under:

"In addition to 50 intake already granted for B.Ed. course from the academic session 2016-17 earlier, the Committee decided that formal permission order under clause 7(16) of the NCTE Regulation, 2014 for applied B.Ed. Programme with another 50 intake from the session 2019-2020 be issued to the institution, thus making the sum total grant of 100 intake."

5. **NOW THEREFORE**, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee, NCTE hereby grants permission to Sant Tapasvi Narayan Das Shikshan Sansthan, Plot No. 3027, 3035, 3026, 3034, 3033, Vill- Dostpur Khairvi, Po- Bariyarpur, Tehsil/Taluka- Bathnaha, Town/City- Sitamarhi, Dist.- Sitamarhi, Bihar-843302 for conducting B.Ed. programme of two years duration with another intake of 50 (existing 50 intake + another 50 intake), thus making total intake 100 (two basic units) from the academic session 2019-2020 under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-


- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDRs shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
  - III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
6. Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc, as applicable.
7. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

  - d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e) Fee charged from students;
  - f) Available infrastructural facilities;
  - g) Facilities added during the last quarter;
  - h) Number of books in the library, journals subscribed to, and additions, if any, in the last quarter;
  - i) The affidavit with enclosure submitted along with application;
  - j) The institution shall be free to post additional relevant information, if it so desires.
  - k) Any false or incomplete information on its website shall render the institution liable for withdrawal of recognition.
9. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website
