Course online on 26.05.2015 for two year duration and hard copy received by Eastern Regional Committee of NCTE on 10.06.2015.

- 2. **AND WHEREAS**, as per the decision of 213th ERC Meeting held on 29th 30th April, 2016 & 1st 2nd May, 2016 formal Recognition order under clause 7(16) for conducting B.Ed. course was issued vide Order No.ER-213.6(i).313/ERCAPP2483/B.Ed. Course/2016/ 46122 dt. 02.05.2016 with an intake 50 (one basic unit) from the academic session 2016-17 to the institution.
